

# **FREQUENTLY ASKED QUESTIONS**

### QUESTION: Where should attendees stay, and do you have a group discount at the hotel?

If you are needing to fly into the area, your options for airports include:

- San Diego International Airport (approximately 40 minutes from the hotel)
- John Wayne Airport (approximately 1 hour from the hotel)
- McClellan-Palomar Airport (10 minutes from the hotel, has minimal commercial flights available through American Airlines)

#### QUESTION: When should I plan on arriving?

ANSWER: We recommend arriving by the **end of the day on Wednesday** before **The Ultimate Level** begins to ensure you're fully rested, prepared and ready to dive in.

Even if you're within driving distance of the event location, we highly encourage you to stay at the event hotel. This will allow you to focus only on the event, experience the **full impact of the 2 days**, and ensure you don't miss any valuable content or networking opportunities.
